Camping fees for the upcoming season were discussed. Motion by Jacobson seconded by Jones to increase camping fees to \$18.00 per night and a 2-week deposit for longer stays. All ayes.

Abandoned properties were updated by attorney Fishman. Fishman sent a letter to the property owners 422 Sherman St. for repairs, no response as of council meeting. Council discussed next options for handling the abandoned property. Petition was filed this week regarding the 510 Sheridan property.
